



## 2018 SYMPOSIUM DISTINCTION AWARDS FREQUENTLY ASKED QUESTIONS

- 1. Is there a fee to enter?** Yes – the design and individual awards are \$195 to enter and the product awards are \$295 to enter.
- 2. If this does not happen timely the submission is removed/declined.
- 3. What is the deadline to submit?** The 2017 deadline is August 17<sup>th</sup> 11:59 PST
- 4. Once I submit an entry, can I edit it?** No, you cannot go back in an edit an entry. Nor can you start an entry, save it and continue later. Please download the word document [here](#). to prepare your entry ahead of time and then copy & paste when you are ready to submit.
- 5. What does Entry Sample URLs mean?** All entries are submitted online, no physical information may be sent. Entry Sample URLs are your chance to submit supporting information such as links to articles, photos, project home pages, etc. Some folks even set up a private website to present supporting documentation for this award. Or you can have it all stored on an FTP site and provide the username and password.
- 6. When will we be notified if we won or not?** All entries will be notified on September 7, 2018 whether or not they won. All notification will be by email to the contact on the original entry.
- 7. When will the winners be announced?** The winners will be announced during the 2018 Healthcare Facilities Symposium & Expo in Austin, Texas
- 8. What does the winner receive?** Each winner of the 2018 Symposium Distinction Awards Receives the following:
